Re: Exemption in the Licentiate, Associateship and Fellowship papers of Insurance Institute of India:

Please refer to your letter COIP/31(7)/2008 dated 7th, October 2008 regarding the above. In this connection we would like to inform you that the matter has been placed before the Competent Authority of our Institute and now we are pleased to inform you that the Competent Authority has decided to grant the exemption from following subjects to the candidates who have completed ACA qualification from Institute of Chartered Accountants of India New Delhi.

- 1. Paper No. 12 Insurance Business Environments
- 2. Paper No. 21 Information Technology
- 3. Paper No. 26 Life Assurance Finance
- 4. Paper No. 89 Management Accounting and
- 5. Paper No. 99 Asset Management

In addition to the above, a candidate possessing ACA Qualification alongwith **DIRM** Program shall be granted additional exemptions from following subjects:

- 6. Paper No. 01 Principles of Insurance
- 7. Paper No. 11 Practice of General Insurance
- 8. Paper No. 82 Statistics

These exemptions will be granted on the basis of following terms and conditions:

Candidates should pass the above mentioned examinations with minimum 50% marks. Original and zerox copy of mark sheet be enclosed with the normal examination entry form for our examination with a covering letter for claiming exemption from the subjects of licentiate Associateship and fellowship examination through Institute of Chartered Accountants of India

The candidate will be required to pay the membership fees, registration fees and exemption fees for the subjects of Licentiate while registering for Licentiate examination. The exemption fees for the subjects of Associateship and fellowship will have to be paid while applying for respective examinations. Other fees and charges as may be payable by them as per rules of the Insurance Institute of India in force time to time.

An application for exemption will be entertained only when it forwarded by Institute of Chartered Accountants of India certifying that the candidate has passed the requisite qualification giving particulars of Roll no., Year of passing, status of qualification and also certifying that the candidate is eligible as per conditions of Insurance Institute of India for exemption in above subjects.
