In response to queries received on Associate Examinations - May 2011 we wish to clarify as follows:

Case No.1: Whether a candidate who had appeared for Associateship General Branch earlier but could not clear any of the subjects, can apply for the new syllabus **or** old syllabus.

Clarification: Candidate can appear either for 'old' or 'new'. If appearing for 'old', he/she has to clear all the papers within the three attempts i.e. May 2011, Nov. 2011 & May 2012.

Case No.2: Whether a candidate who had appeared for Associateship Fire/Marine/Misc. Branch earlier but could not clear any of the subjects can apply for the new syllabus or old syllabus.

Clarification: Candidate can appear either for 'old' or 'new'. If appearing for 'old', he/she has to clear all the papers within the three attempts i.e. May 2011, Nov. 2011 & May 2012.

Case No.3: Whether a Candidate who has already passed General Insurance papers of No.57/67/72/78/71/74/77 (Which are in both old and new syllabus) can appear in the old syllabus **or** appear in the new syllabus opting for paper nos. 45/46/47.

Clarification: Candidate can appear either for 'old' or 'new'. If appearing for 'old', he/she has to clear all the papers within the three attempts i.e. May 2011, Nov. 2011 & May 2012. If appearing for 'new' he/she has to take three compulsory papers and three optional papers (whichever he/she has not cleared).

Case No.4: Whether a candidate who has passed paper no.(s) 21/79, can appear in the new syllabus and will he get any exemption or he has to forego the papers in which he had already passed.

Clarification: Candidate can appear either for 'old' or 'new'. If appearing for 'old', he/she has to clear all the papers within the three attempts i.e. May 2011, Nov. 2011 & May 2012. If appearing for 'new', candidates who have passed IC 79 will get exemption in IC 74 or IC 77. There is no provision for granting exemption for passing in IC 21 and he/she has to appear Compulsory paper no IC 47.

Case No.5: Whether a Candidate who has already selected a particular branch (Fire/ Marine/ Misc.) and cleared some papers can opt for the balance papers from the new syllabus?

Clarification: As there is no corresponding branch in the 'new' syllabus, the candidate cannot appear under 'new' syllabus. He/She has to clear all the papers within the three attempts i.e. May 2011, Nov. 2011 & May 2012. If opting for 'new', he/she has to appear for all such papers under 'new' syllabus where he is not eligible for exemption.

Case No.6: Whether a Candidate of Life branch who had cleared some papers can opt for the balance papers from the 'new' syllabus or 'old' syllabus?

Clarification: Candidate can appear either for 'old' or 'new'. If appearing for 'old', he/she has to clear all the papers within the three attempts i.e. May 2011, Nov. 2011 & May 2012.

If opting for 'new', he/she has to appear for all such papers under 'new' syllabus where he is not eligible for exemption.

Exemption is allowed only for those who have passed subjects IC 22, IC 23, IC 24 and IC 26. As there is no provision for granting exemption for passing in IC 21 and IC 25, Candidates have to appear in IC 28 instead of IC 21 and IC 27 instead of IC 25.
